11h :00 Drive to the quaint village of **Esles. Visit the private gardens of the Gonzalez Camino family who will host lunch.** Welcome by landscape architect Luis Gonzalez-Camino.

In the afternoon we will see the garden and studio by artist Manuel Saro and the late artist Fernando Bermejo.

11h :30. Continue to **Santillana del Mar** for a walk through the village and a visit to the Romanesque Collegiate church and its beautiful cloister. Will also visit Jesús Polanco & Pancho Pérez Gonzalez contemporary art collection at **Torre de Don Borja**, with a welcome by Director Marcos Diez. It has a beautiful walled garden. We will also see the gardens of the Archiduquesa of the antique dealer Antonio Cabrero.

14h:00. Lunch of regional specialties at the Parador Restaurant.

In the afternoon we will drive to the lovely town of **Comillas**. It came into fashion at the end of the 19<sup>th</sup> century through Count Guell, Gaudi's patron, and Antonio Lopez y Lopez, first Marquis of Comillas and Gaudi's father-in-law. Visit La Pelegrina private garden.


1pm. Stroll through the village and see the Church of San Salvador.

18h:00. Return to San Sebastian. Dinner on your own.

#### 6. SUNDAY 29 JUNE: San Sebastian - Bilbao- Oporto/ Lisboa.

8h:30 Departure by coach. Enjoy a scenic drive to Bilbao. (1h15m approx.).

#### **TERMS AND CONDITIONS:**

This document must be **returned signed** by **CLIENT** with the confirmation of the trip. Once the trip is confirmed by **CLIENT**, the deadlines, conditions and cancellation policy on this document must be fulfilled. If the conditions stated on this document are not followed, Around Art reserves the right to cancel the trip for the benefit of our clients, providers and company.

The price of the trip is per person, based on a minimum of 15 or 18 participants in double occupancy to cover everything outlined in the itinerary. If this minimum is reached or exceeded, the price per person will remain the same, meaning that even if there are more than 20 participants, each person will pay the individual price. For example, if there are 16 or 19 participants, each will pay the same per-person price calculated for the minimum of 15/18 participants.

CLIENT is responsible for publicizing this trip to those deemed appropriate by CLIENT and for recruiting a minimum number of participants as stated above in this document. In addition to stipulations concerning minimum participation as noted above, if CLIENT makes refund arrangements between itself and the trip participants other than stated in this contract, the costs of these arrangements are to be born totally by CLIENT If numbers fall below the minimum and if CLIENT decides to nevertheless proceed with the trip, will be responsible for meeting the budgeted costs and terms stipulated and will decide in collaboration with Around Art, what, if any, changes need to be made in the itinerary.

Notification of a minimum or more participants must be given to Around Art by 6 MESES ANTES

Around Art will make every effort to execute the itinerary as planned. Around Art reserves the right to make substitutions, as necessary, in consultation with <a href="CLIENT">CLIENT</a> representative in case of cancellations or unforeseen problems, as they arise.

#### **CANCELLATION CONDITIONS**

If the cancellation of a traveller reduces the group size below the minimum number of paying participants required for the trip, the following conditions will apply:

The cancelling client must either find a substitute to take their place or cover their proportional share of the general costs allocated to them in the trip budget.

This is necessary to prevent an increase in the price for the remaining participants, as the trip's cost structure is based on a minimum number of paying clients.

If no substitute is found and the group falls below the required minimum, the cancelling client will be responsible for the shortfall, in addition to any applicable cancellation penalties outlined in sections a) and b) below.

These additional conditions ensure that all clients fairly share the costs of the trip, avoiding unexpected price increases for the remaining participants.

We strongly recommend that you take out a cancellation insurance policy at the time of registration to cover the costs of reducing the group.

#### **Additional Cancellation Conditions**

The traveller may terminate this contract before the start of the package, and the organizer and / or the retailer may demand a penalty consisting of:

- a) Pay the management fees (valued at € 20 per person for trips of up to € 300 price; € 60 per person for trips of up to € 1,000 price; € 100 per person for trips of up to € 1,500 price; and € 150 per person for trips of € 1,501 or more price), cancellation -if any, See section b) below at this same point- and a penalty consisting of:
  - a.1. 5 percent of the total amount of the trip, if the cancellation occurs more than twenty days before the date of the start of the trip and after twenty days of the contracting of the same;

- a.2. 10 per cent if the cancellation occurs more than ten and less than twenty days before the start date of the trip;
- a.3. 20 per cent between days three and ten days before the date of commencement of the trip, and
- A.4. within forty-eight hours prior to departure, the amount resulting from the price of the package less cost savings and less revenue from the alternative use of travel services.
- b) In addition to the amounts accrued by the percentages agreed above, the traveler must pay for tourist services that are subject to special economic conditions of contracting and cancellation and that do not allow the reimbursement of what was paid for such concept.
